- (4) The WRITER warrants that he/she is the sole owner and author of the MATERIAL and that he/she has the full right and authorization to submit it to the COMPANY.
- (5) Any part of the MATERIAL which is not novel or original, and therefore not legally owned or protected, may be used by the COMPANY without any liability on its part to the WRITER. Nothing herein shall place the COMPANY in any different position with respect to such non-novel or non-original material by reason hereof.
- (6) The COMPANY shall not be under any obligation to the WRITER with respect to the MATERIAL except as may later be set forth in a fully executed written agreement between the parties.
- (7) The COMPANY may have had access to and/or may have independently created, or have had created, ideas, themes, formats, and/or other materials which may be similar to the theme, plot, idea, format, or other elements of the MATERIAL now being submitted by the WRITER. WRITER agrees that he/she will not be entitled to any compensation by reason of the use by the COMPANY of any such similar material.
